# Raising Wages:

# A Working People's Agenda for Shared Prosperity for All

Times have been hard for North Carolina's working families. The last sessions of the legislature have not helped and have even made those times harder. Legislators have radically slashed unemployment benefits, undermined our public schools, changed the tax code to benefit the wealthy, denied Medicaid benefits for 500,000 North Carolinians, enacted the most draconian voter-suppression law in the nation, eliminated incentives to keep good paying jobs in the state, enacted needless expansions of the socalled right-to-work law, passed the infamous HB2, failed to address the growing problem of employee misclassification, enacted broad "ag-gag" legislation, and made laws making life even more difficult for immigrant workers.

Decisions made by the General Assembly in the upcoming 2017-18 session will again be critical in determining the future of working families in our state. As in the past, the N.C. State AFL-CIO will be one of the few voices for working people at the legislature.

Our legislative agenda addresses the most fundamental needs of North Carolina's working people: good paying jobs, strong workplace protections, and an adequate safety net.

Given the political realities of our state, we realize our goals aren't easy to achieve. This will be a long-term effort. Talking about policies that address income inequality is a good place to start, and two steps in this direction need to be priorities for this session.

#### **Our Priorities**

1). Raise the minimum wage to \$12 an hour by 2020 and \$15 by 2022, phased in at about \$1.55 per year.

North Carolina should join the 29 states that have decided to raise their minimum wages. Those states have recognized that the current federal minimum wage of \$7.25 (or \$15,080 a year) keeps people in poverty and is wholly inadequate. This is particularly important in North Carolina where the majority of jobs created in the past 7 years pay low wages. Raising the minimum wage helps local economies by putting money in the pockets of residents most likely to spend it in their communities. It is also an issue that polls show the majority of Americans and North Carolinians support.

# 2). Restore unemployment benefits that were slashed in 2013 because the program now reaches <u>too few</u> jobless workers for <u>too short</u> a period and provides those jobless workers <u>too little</u> in payments.

At one point, the fund from which unemployment benefits are paid was broke, largely because taxes on employers were inadequate to deal with the recession. The legislature's answer was not to ask more from employers, but to dramatically cut the amount and duration of benefits and make it more difficult to be eligible for any benefits at all. The fund is now fully solvent - meaning at least some of the benefit cuts, which put our state among the worst in the country, should be restored. For example the duration of benefits should be returned to 26 weeks, the formula that calculates the weekly check amount should be changed, the maximum amount that an unemployed worker can receive should be increased, multiple waiting weeks should be eliminated, and eligibility for those who must leave work due to a family hardship should be restored.

The rest of our agenda outlines other important areas that ought be addressed.

#### **Good Jobs**

The people of North Carolina deserve good jobs that are reliable and pay family-sustaining wages. Far too many good jobs, especially in the manufacturing sector, have been lost, and far too many people are unemployed or working at replacement jobs that provide lower pay and less stability. Therefore, legislators should:

- Repeal HB2, which prohibits local governments from ensuring that companies with which they contract provide decent wages and benefits.
- Require companies receiving tax incentives to provide jobs that will raise, not lower, the standard of living of working families
- Expand apprenticeship programs and focus workforce development efforts on skills that enable workers to move into good-paying jobs.
- Create work-sharing programs that will keep people employed, preserve the skills of our workers, and reduce both lay-offs and costs to employers.

#### **Worker Protection**

We urge policymakers to strengthen worker protections and safeguard fundamental labor rights so that workers receive the pay and benefits they deserve. Therefore, legislators should:

- Stop workplace fraud resulting from wage theft and misclassification of employees. Workplace fraud cheats people out of workers' compensation and other protections, penalizes honest employers and is estimated to cost our state \$467 million each year in lost revenue.
- Maintain a stable workers' compensation system which pays adequate benefits to those injured on the job.
- Insure workplace safety and health for all, including our migrant workers.
- Guarantee a minimum number of paid sick days for workers to care for themselves, their children, and their parents.
   Expand the definition of "family" in the FMLA to allow leave to care for siblings, grandparents, or grandchildren - while preserving the exemption for family farms.
- Provide funding for child care subsidies to offset the cost of affordable, quality child care for low income workers and those pursuing training.
- Use savings from the Justice Reinvestment Act to provide a coordinated delivery system of re-entry services to individuals with criminal records and expand expungement opportunities for rehabilitated individuals.
- Allow governmental entities that wish to do so to enter into collective bargaining agreements with their employees.

#### A Strong Safety Net

If workers earned decent wages, tax revenue would increase and the need for public assistance would decrease, but in this low wage economy, the opposite is true. Too many families are struggling to make ends meet, and if severe budget cuts continue, many of our citizens will lose the help they depend upon for their survival. Providing necessary support to the most vulnerable establishes a lifeline to families in need and also helps stimulate local economies. Therefore, legislators should:

- Protect vital services for the elderly, children, and those with special needs.
- Improve our tax code to insure adequate revenue and progressive, fair taxation. Do not reduce or eliminate personal and corporate income taxes. Reinstate the Earned Income Tax Credit. Close loopholes that allow large corporations to avoid paying their fair share.
- Increase access to health care for the uninsured by expanding Medicaid.
- Provide adequate funding for appropriate educational services for all students, expand pre-K for all children, insure that public revenue is used exclusively for public schools and not to support private education, and stop for- profit education schemes, including virtual schools.

#### A Fair and Open Democracy

If we want policies that enable working people to enjoy the fruits of their labor and to pursue their own happiness, it's important to have a fair political process that is not unduly influenced by corporate interests. We believe in a government of, by, and for the people. For that reason, we oppose any efforts that make it harder for citizens to exercise their right and responsibility to vote and encourage efforts to reinstate public campaign financing so that working people can run for office. We also oppose gerrymandering and support the establishment of an Independent Redistricting Commission to draw legislative and congressional boundaries.

#### **Consumer Protection**

We've seen how unscrupulous lending practices have damaged our economy and ruined many people's lives. More than ever we need to guard against predatory lending, the unnecessary garnishment of wages, and other abusive lending practices that take hard-earned wages out of the pockets of working people.

#### **Federal Issues**

We recognize that much of our job on a federal level will be to fight against anticipated legislation by the new administration and new Congress that will be aimed at crippling unions and threatening the wages and benefits and the job security of union members, and indeed, all working people. We will oppose any attempts to undermine wage standards or ship jobs overseas through unfair trade deals. We will work to protect

Social Security, Medicare, and Medicaid. We will fight for fair wages and working conditions for federal employees as well as to protect their representation and bargaining rights.

The election makes our task as difficult as ever - but perhaps more important than ever. We are counting on you, our members, to make that task possible. Together we can help protect and improve life for all working people.
