



## Sponsoring the “House of Labor”

The NC State AFL-CIO is exploring options to help establish a sustainable and diverse funding stream that can grow our capacity to execute our vision to **build a bigger, more engaged, more powerful labor movement that can win victories for North Carolina working families** by:

- Growing the movement
- Engaging and mobilizing our leaders, our members, and community allies
- Building independent political power

In order to help make this vision a reality, the NC State AFL-CIO is introducing an opportunity to “Sponsor the House of Labor.”

The first round of building sponsorships will be announced at our 62<sup>nd</sup> Annual Convention, September 19-20, 2019 in Charlotte, with plaques awarded to affiliate representatives and mounted in the building in October and November 2019.

### Have your union’s name and logo proudly displayed at the NC State AFL-CIO!

Built in 1914, our office is your North Carolina federation of labor’s greatest asset, valued at approximately \$800,000. Now, affiliated International Unions and Local Unions, as well as individual union members, are eligible to sponsor one or more rooms in the “House of Labor,” the headquarters building of the NC State AFL-CIO, located at 1408 Hillsborough Street, Raleigh, NC 27605.

Annual sponsorship fees are based on square footage and visibility. Sponsors will have their name and logo (logo applies to affiliates only) visibly displayed on a plaque in the designated space for the duration of the sponsorship. **Sponsorships are priced at an annual fee, and the commitment for a sponsorship is for two years.** Sponsorships are available on a first come, first-served basis and can be renewed, unless a waiting list develops.





Sponsoring affiliates must remain in good standing for the duration of their sponsorship. Any breach of the Code of Ethics may make a sponsor ineligible for sponsorship, at the discretion of the Principal Officer. In the event a sponsorship is revoked, the term will be prorated, and the sponsor will be reimbursed for the ineligible period.
